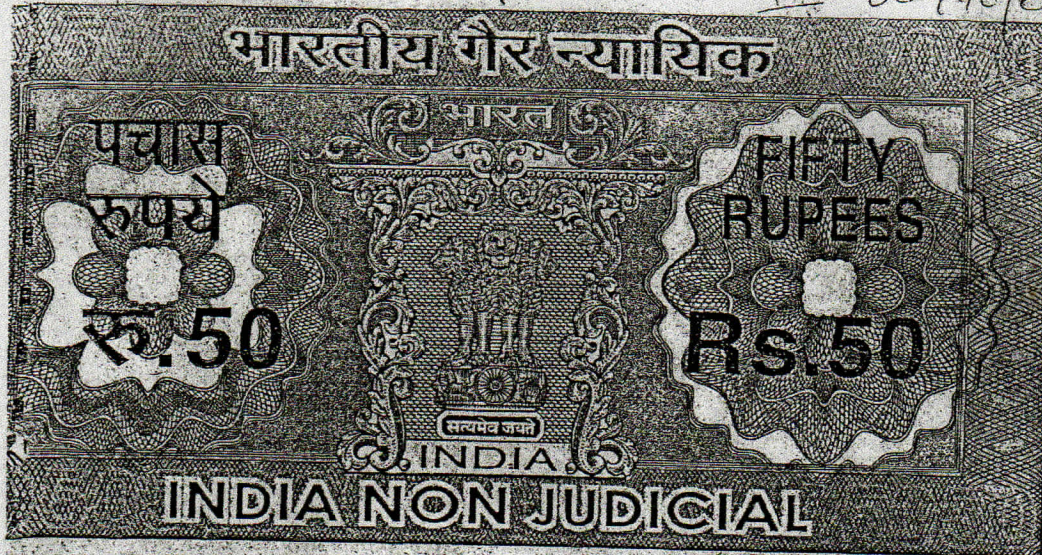

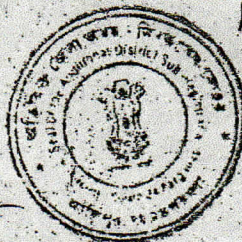

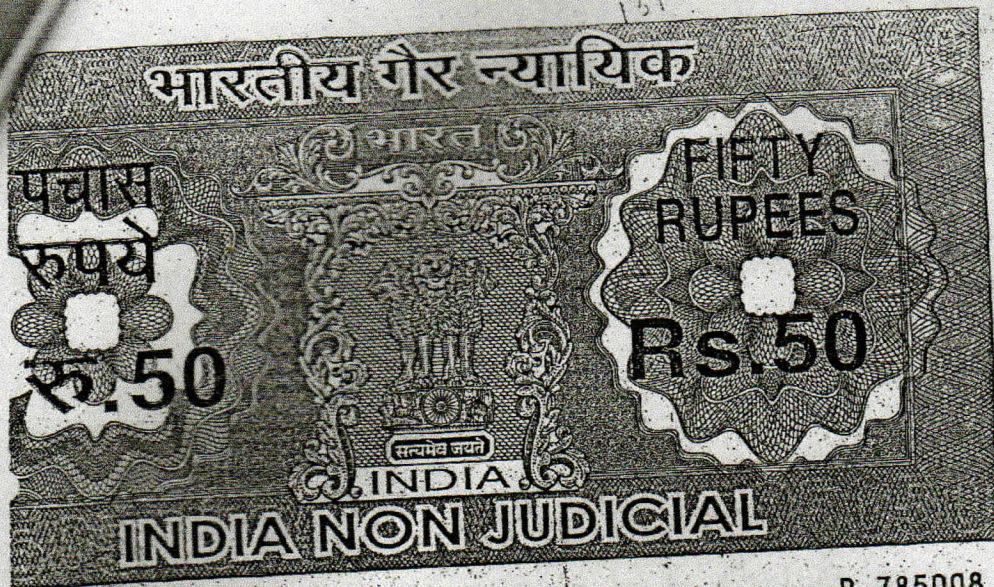

OTHER PART.

WHEREAS

1. The Settlor has long desire to create a Trust to provide for and/or impart professional, vocational and technical education to the public at large in several fields, more fully and particularly stated in the objects clauses hereunder written and for such purpose the Settlor has made over a sum of Rs. 2501/- (Rupees Two thousand five hundred one only) as Corpus of the Trust Fund to the Trustees by way of initial contribution.
2. The Trustees above named have at the request of the Settlor agreed to act at the trustees of these presents and to hold the said sum of Rs. 2501/- (Rupees Two thousand five hundred one only) and the investment for the time being representing the same and all other sums as properties that may from time to time from part of the Trust fund upon the Trusts hereafter declared of and concerning the same.
3. The Settlor considers it fit and proper to execute a regular Deed of Trust specifying the diverse objects of the trust and also the rights and duties of the Trustees.
4. The Registered Office of the Trust will be at 12, Prannath Pandit Street, Police Station - Bhawanipur, Kolkata - 700025, which may be shifted to any other place if the Board of Trustees may decide subsequently to suit the official business and purpose of the trust.

NOW THIS DEED WITNESSETH AS FOLLOWS:

- (1) That the Settlor does hereby transfer, assign and make over unto the Trustees the sum of Rs. 2501/- (Rupees Two thousand five hundred one only) to have and hold the same and the investments for the time being representing the same and all other sums of properties that may from time to time form part of the Trust - Estate unto the Trustees upon the Trusts and with and subjects to the powers, provisions and declarations hereinafter contained of and concerning the same.

- (2) The name of the Trust shall be **SWAMI VIVEKANANDA INSTITUTE OF SCIENCE AND TECHNOLOGY**

3. OBJECTS OF THE TRUST:

- (3.1) The Object of the Trust shall be to impart, promote and spread education in Engineering, Management, Technology, Medical, Bio-technology, Vocational Training, Technology, science, Research Institute, Surgical Operation, Computer Science and to

establish manage and run the school and college for boys and girls, libraries, reading and to promote education, social economic and vocational need.

The other Objects of the Trust shall be relief to the poor, advancement of education; al relief and advancement of any other object of general public utility not involving carrying on of any activity for profit in India and the Trust is not for the benefit of any particular religion, community or caste.

Without prejudice to the generality of the foregoing, the objects of the Trust shall be all of the following:-

To acquire, establish and maintain one or more hospital/hospitals for the reception and treatment of persons suffering from illness, mental defects, blood disease, or for the reception and treatment of person during convalescence, or of person requiring medical attention, or education, solely for philanthropic purpose and not for purpose of profit.

To provide medical relief to the Public in all branches of medical sciences by all available means.

To carry out medical Research by engaging in the research and development of all fields of medical science, and in all therapies of medical treatment, so as to afford medical relief in any way.

To provide research facilities for carrying on research basic and applied, in all systems of discipline of medical and surgical knowledge, keeping in view the socio-medical and socio-economic needs of the afflicted community.

To found, establish or takeover, or takeover, and/or otherwise conduct research institutions in all discipline of medical and surgical knowledge.

To encourage and develop biological and pharmacological standardization of indigenous medicinal plants.

To encourage the discovery of new medical and surgical management of diseases and to investigate and make known the nature and merit of investigations and findings and research in the field and to acquire any patent and licences or other protective devices relating to the results of discovery, investigations, findings and researches and to acquire any processes upon such matters as may seem expedient and to improve the same and to undertake the manufacture of any article developed, discovered or improved and/or to give licences for the manufacture of the same to others and either to market the same or to grant licences to others to market the same on terms as the Trust may deem it fit to do.

To conduct and to carry on experiment and to provide funds for research works and for scholarship, stipends, remuneration and or other payments or aid to any person or persons engaged in research works, or work connected with or conducive to research and to encourage and improve knowledge of the persons who are engaged or likely to be engaged in any medical or allied profession so as to make available medical relief to the Public at large.

 establish and maintain or support or help by monetary gifts or otherwise, play public parks sports and games and other social welfare works;

to establish and maintain or aid or support or help the establishment or maintenance of centres, centers, auditoriums, wells, tanks, roads and the like for the rendering of to the general public;
 to establish and maintain, or support, or help or aid in the establishment or maintenance of buildings premises, homes hostels and the like for the benefit of students;

To establish, support, maintain and/or assist financially schools, colleges, centres, centers, libraries, vocational institutions for the advancement of education and dissemination of knowledge in arts, sciences, literatures, humanities and all other useful subjects and other manifestations;
 To grant scholarship, stipends, prizes, rewards, allowances and other financial assistance to students;

To provide help and assistance in cash or kind for marriage of poor girls, widows, and/or poor and destitute people;

To provide food, clothes, medicines and other help and/or assistance in any shape or form to the poor persons irrespective of caste, creed and religion.

To give monetary and/or other help for relief on occasions of natural and other calamities such as flood, famine, cyclone, earthquake, epidemic, storm, accidents, and/or other emergencies; donations, subscriptions or contributions to institutions, establishments or persons doing work on such occasions;

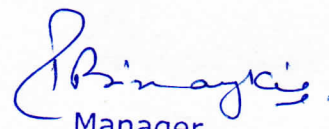
To do all such acts and things as may be conducive to the attainment or furtherance of all or any of the objects of the Trusts subject to the restriction contained in clause 3.3 under written.

It is expressly declared that Trustees are not authorised to do a work which is not of Public Charitable nature and no part of the trust properties or its income shall be applied for any purpose and nothing herein shall be construed to authorise the Trustees to utilise the Trust assets or its income where by it will forfeit exemption under the income tax or wealth tax Act. All the powers and provisions hereof shall be construed as being subject to and restrictions and limitations herein contained.

A Trustee shall be disqualified from continuing as a trustee or shall cease to be a trustee on the happening of any of the following events:

- Death;
- Physical or Mental infirmity;
- Resignation;
- On being rendered incapable to perform the duties of a Trustee
- On being convicted in a court of law of any offence involving moral turpitude
- On failure to attend four consecutive meetings of the board of trustees without leave of absence;
- On being adjudged insolvent.

5. If at any time the number of Trustees should fall below three, the continuing Trustees shall fill the vacancy which they are authorised to fill before transacting any other business and all acts, matters and deeds done and/or performed by the continuing trustees during the period of the vacancy or vacancies shall be deemed valid if they are otherwise in accordance with these presents.

7. On the appointment of a Trustee or Trustees to fill a vacancy or vacancies the Trust property shall stand transferred and/or become vested in the newly appointed Trustee or trustees, as well with powers of these presents to act as fully and sufficiently as if the new trustee or trustees had hereby been constituted as a trustee or trustees.

8. The trustees shall hold meetings of the Board of trustees from time to time as may be necessary but shall hold at least four meetings in a year. The quorum for a meeting of the Board of Trustees shall be 1/3 of its total strength. Any alteration or amendment to the Constitution of the Trust any major decision for running of the Trust shall require a minimum support of 2/3 of its total strength of the Trust. The Board may frame rules and regulations for the conduct of its meeting.

5.9 The trustees shall keep or cause to be kept a minute book of their proceedings.

5.10 Every Trustees will be at liberty to resign by giving one month's notice of his intention so to do and shall be entitled to appoint any eligible person to act as the trustee in its place.

5.11 A meeting of the Board of Trustees shall be convened as and when required, or at the instance of the Chairman or Secretary, or on the requisition in writing of any three Trustees setting out clearly the subject or subjects for which the requisitioned meeting is sought within fifteen days of the receipt of such requisition.

6. POWERS AND FUNCTIONS OF THE TRUSTEES:

6.1 The Board of Trustees shall have all powers appropriate and necessary for the fulfillment of any or all of the objects of the Trust or necessary and appropriate for the effective and efficient administration of the trust matters and affairs. Without affecting the generality of such powers and functions, the Board of Trustees shall have the following powers and perform the following functions:

accept donations, contributions, grants, subscriptions or any aid or assistance or in kind from any person.

To apply the whole or any part of the income or accumulation thereof or the whole part of the corpus of the Trust property or fund for one or more of the objects of the trust as the board of Trustees may determine from time to time;

To control, manage and superintend all the activities of the Trust and the Income tax and functions of the Trust;

To invest and keep invested the Trust fund or such part thereof as is not immediately required to be spent in the manner hereinafter provided;

To purchase, acquire or to sell; dispose of, alienate or otherwise deal with any property movable or immovable, comprising the Trust fund and to delegate any Trustee for such purpose;

To let out or demise any immovable property comprised in the Trust fund for the period for such period, and on such terms and conditions as the Board of Trustees or any Trustee thereof in this behalf shall think fit and proper for the benefit of the Trust;

To frame Rules and Regulations including fee structures, authorising any one or more Trustees to look after finance and day to day administration & activities.

To open an account or accounts with any bank or banks, to operate such account or accounts whether in debit or in credit and to give all appropriate instructions to the banker or bankers concerning the operation of such account or accounts and to authorise by appropriate resolution one or more of the trustees jointly or such trustees jointly with an agent appointed by the board of trustees in this behalf to operate such account or accounts.

To arrange for and/or authorise the signing or execution of any agreement, contract, deed, document or any other paper or writing required to be signed or executed on behalf of the Trust by any of the trustees to be nominated in this behalf by the board of trustees and to be the same effective and binding as if the said agreement, contract, instrument or deed or paper or writing were signed by all Trustees.

To adjust, settle, compromise, compound, refer to arbitration actions, suits, claims, disputes, differences and proceeding regarding the properties and affairs of the Trust;

To appoint constituted attorneys or agents or servants, to delegate to such attorneys or servants, all or any of the powers vesting in the trustees under these presents from time to time remove such attorneys or agents or servants and to appoint another or others in their place and to fix their duties, responsibilities and the terms and conditions of employment;

To appoint or make provisions for the appointment of a sub-committee or sub-committees of Trustees and/or others to attend to or supervise or conduct specified jobs or business or trust matters in such manner and subject to such rules and regulations as the board may prescribe;

To authorise any of the trustees to hold any property or any fund or any investment of the Trust subject however to the terms of these presents in such manner and subjects to such rules and conditions; rules and regulations as the Board of Trustees may from time to time think fit and proper;

To make, alter, amend or modify or repeal schemes, rules and regulations, bye laws or carrying out the objects of the trust and for the management of the affairs thereof and running any institution, academy, in furtherance of the objects of the trust or giving effect to the objects of the trust;

To set apart the whole or a part of that income or corpus or part thereof for any of objects of the trust;

To spend any portions of the corpus or the income of the trust fund for purchasing and and/or constructing any building or buildings for and in the name of the trust for purpose of carrying out, promoting and/or executing any or all of the objects of the trust;

To invest the moneys belonging to the trust including the reserve fund if any and/or additions or accretions to the trust fund and/or any funds not immediately required for purposes of the trust and/or all surplus moneys in such form or mode, in such manner and such periods as prescribed and/or allowed from time to time under the provision of the Income Tax Act;

To settle out of court or compound suits, actions and other proceedings and all claims and demands and to refer any or all of such differences or demand to arbitration and just settle and approve all accounts relating to trust fund or trust properties and to execute and do all other acts and thing relating thereto as if they were absolutely entitled to the trust funds and properties and without being answerable for any loss or losses occasioned thereby;

To take all steps necessary for the preservation and safety of the trust fund and trust properties and to effect such insurance in the trust properties as the trustees may think fit and proper;

To keep and maintain proper books of accounts in which shall be entered all items of income and expenditure of the trust and to get such accounts audited at the end of each year;

To demand realise and receive interest and other income of the trust from such persons who are liable to pay the same and to realise the same from public debt office;

To take on hire or rent any property to carry out the objects of the trust on such terms and conditions as the trustees may deem fit and proper.

GENERAL PROVISIONS

The receipt of a person authorised by the Board of trustees in this behalf for any moneys or any property transferred or delivered to the trustees or for the purchase moneys of any property authorised to be sold shall effectually discharge any person or persons so paying or giving or delivering.

The Trustees shall not be entitled to receive any remuneration as trustees but may reimburse themselves of expenses actually incurred by them in connection with the work of the trust or duties relating thereto.

The trustees shall be respectively chargeable only for such money, stocks, funds, securities and income or any trust property as they respectively actually receive notwithstanding giving any receipt therefore for the sake of conformity and shall be answerable, chargeable and accountable for their own acts, receipts, neglects, or defaults and not for those of each other, those of any banker, broker agent or other person or persons in whose name or in whose names the moneys or securities or properties may be placed nor for the insufficiency or deficiency of any stocks, funds, share or securities of any other property nor for the depreciation or voluntary loss unless the same shall happen by their willful default or neglect.

The financial year of the trust shall be April to March provided, however, the Board of trustees shall be at liberty to change the same from time to time if they do deem fit and proper.
